AUTHORIZING PAYMENT OF COMPENSATION TO ATTORNEYS**

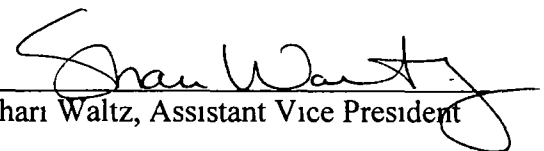

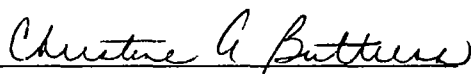
