**APPLICATION OF TRUSTEE SEEKING AN ORDER FIXING AND
AUTHORIZING PAYMENT OF COMPENSATION TO ATTORNEYS**

Now comes Fifth Third Bank, Trustee of the Trust U/W of Ethan Stone fbo Various Charities, by its Trust Officer, Beth Bidleman, and hereby makes application for an Order of the Court fixing and authorizing the payment of compensation to the attorneys for the Trustee for legal services rendered on its behalf for the period of the Twenty-Ninth Current Account from January 1, 2004 through the filing of the account on February 15, 2007.

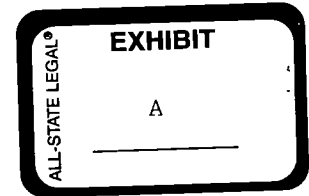
