Now comes The Fifth Third Bank, Successor Trustee under the Last Will and Testament of Ethan Stone, Deceased, and respectfully represents to the Court that, as provided in said Will of Ethan Stone, Deceased, and in accordance with the order of this Court and the several decrees of the Court of Common Pleas of Hamilton County, Ohio, entered in Case No. 95351 and in Case No. A-4904, an election was duly held by said Trustee on October 19, 1993, among the Protestant communicants of former Storrs Township in Hamilton County, Ohio, to determine the recipient of certain income from said trust estate known as the "Church Fund" for the ten-year period next ensuing from May 1, 1994, the last previous such election having been held on December 16, 1983, as a result of which a recipient was designated to receive said income for the ten-year period ensuing from May 1, 1984.

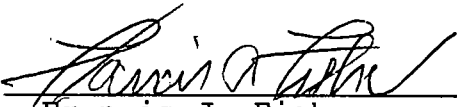
Said Trustee further represents that on each of the days of October 1, October 8, and October 15, during the period of three weeks prior to such election, it caused notice thereof to be given by publication in The Cincinnati Post, a newspaper of

general circulation in Hamilton County, Ohio, containing a statement of the hours and polling places of such election, a copy of which notice is hereto attached and made a part hereof, that on October 19, 1993, said Trustee caused said polling places to be opened at the time and at the places mentioned in said notice for the casting of votes by the persons entitled to vote at said election, and supplied each of said polling places with a sufficient number of uniform ballots, prepared under the direction of this Court, a copy of said ballot being attached hereto and made a part hereof, and also supplied to such polling places necessary accessories for the marking of said ballots; that the Trustee selected and appointed three proper persons at each of said polling places mentioned in such notice, to serve as judges of the election and that said judges in turn selected and appointed two proper persons at each of said polling places to serve as clerks of the election, all as provided in the aforesaid order of Court; and that such election, so held, resulted in votes being cast, as per exhibits attached hereto, as more fully appears from the poll books and certifications of the judges and clerks of said election.

WHEREFORE, said Trustee prays the Court to determine and designate the proper recipient of said Church and for the propagation of the Protestant religion in said former Storrs Township in Hamilton County, Ohio, as provided under said Will of Ethan Stone, Deceased, for the ten-year period next ensuing from

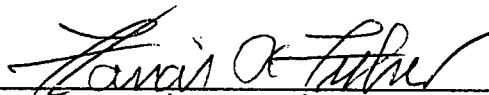
May 1, 1994, and for all other necessary and proper orders in the premises.

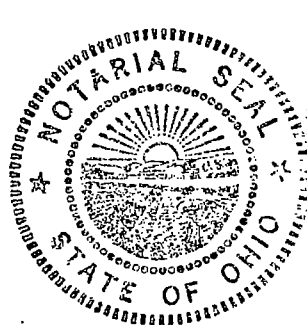

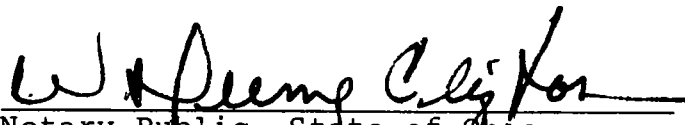
