**Application of Trustee Seeking an Order
Fixing and Allowing Compensation to Attorneys**

Now comes The Fifth Third Bank, by Kristina W. Baldwin, its Trust Officer, Trustee of the Trust U/W Ethan Stone, and makes application allowing compensation for its attorneys for services rendered to the Trustee concerning the administration of said trust during the period covered by the Twenty-Fourth Current Account, March 1, 1995 through February 29, 1997.
