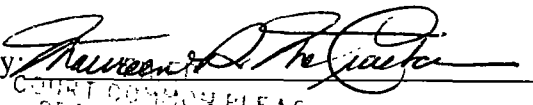
PNC Bank, N.A., Trustee under the Will of Ethan Stone, deceased, applies to the Court for authority to pay attorney fees as follows:
