Jackson's East line and the rents & issues therey forever, excepting therefrom the lot called the Perry lot, and the ground lying back of it, now the property of A. Taft & John P. Stwater, and likewise excepting what is known as the Pasture lot, lying North of the Chapel and between the Creek & said Tho M. Jackson's East line, which said pasture lot I hereby give and devise to the said Thomas M. Jackson and his wife Maria Jackson; And I also give & devise to said Township the lots on which the family of Mr Cook pay rents amounting to fifty one dollars per annum, under perpetual lease, which last mentioned lots lie next west of the property of the said Thomas M. Jackson, where he now resides, And likewise the lots on which Lytle Lodwick now resides, ~~the same being let on perpetual leases for an~~ amounting to thirty one dollars per annum, which grounds have by given and devised to said Township of Storr are all subject to perpetual leases ^{by a lease} and yield an annual income of about Twelve Hundred Dollars exclusive of the lot of the Rev Horace Bushnell, on which lot no rent will be due for several years, & the rents upon which when they shall become due, I hereby bequeath to the Township of Storr for the support of the poor of said Township. The above described grounds, given and devised to said Township of Storr, together with all the rents and issues thereof forever, subject to the exceptions aforesaid, are given and devised upon the following express conditions and trusts: to wit, That the said Township of Storr shall pay to the Trustees of the Ministerial Section for Cincinnati Townships, Forty Dollars per annum, as the same shall become due as rent on my lease for said Fractional Section Twenty Nine, forever, And that the said Storr Township shall also pay to the ~~Cincinnati~~ ^{Cincinnati} Orphan Asylum of Cincinnati, ~~called the~~ Cincinnati Orphan Asylum, One Hundred Dollars per annum forever, And to the Society for the Relief of the Blind and Indigent Females, Sixty Dollars

for annum, for ever; And that the rest and residue of said annual income, being about One Thousand Dollars per annum, the said Township of Stens, shall hold in trust, one half thereof for the support of the Protestant religion in said Township; and one half thereof for the support of one or more protestant schools in said Township. Number Twenty Nine: And that to avoid disputes, or any division of the fund thus devoted to the support of religion, it be decided once in every ten years by a vote of all the Protestant Communities of said Township, who may choose to vote, to what denomination of Protestants Christmas, said fund shall be appropriated for the ten years next ensuing said election.

I give and bequeath my books to my niece Louisa Pease and to John P. Atwater, to be equally divided between them.

It is my will that Mrs Mary Fanar shall be furnished from my estate with board and lodging while she and my niece Louisa Pease shall keep house together, and when they shall cease to keep house where we now live, that one bed and bedding and bedding furniture complete be given to the said Mary Fanar, and that one bed and bedding furniture be also given to Lucy Jane Atwater, and that all the rest and residue of my household furniture of every name and nature, whatever, be given to my said niece Louisa Pease, without appraisal or sale.

It is my will, that while the House and lots where I now live shall be occupied by my niece Louisa Pease and Mrs Mary Panar according to the provisions of my said Will and testament, the taxes and assessments upon said House and lots; together with the Insurance and repairs shall be paid by my Executors out of my estate: and all the remainder of the rents and profits and receipts from my estate, real and personal, not specifically bequeathed or devised, after the payment of the specific legacies, shall be by my Executors collected and invested for the benefit of the residuum, which is to be distributed when my said niece Louisa and Mrs Panar, shall cease to occupy my said House & Lots as aforesaid.

It is also my will, and I hereby direct, that my Executors set apart, and reserve in their hands, as Trustees, a sufficient amount of my Rail Road Stock to produce by dividends, Fifty Dollars per annum, and that they collect the dividends thereon, and pay over, to Frances Morgan, grand daughter of my deceased Brother, Charles, or to her order, in Cincinnati, Fifty Dollars a year during her natural life, the first payment to be made two years after my decease, provided that no money shall be paid over except upon her own order, and that no money shall be paid for any fraction of a year: And after her decease, the said Stock shall be sold and distributed to my six extraordinary residuary Legatees.
