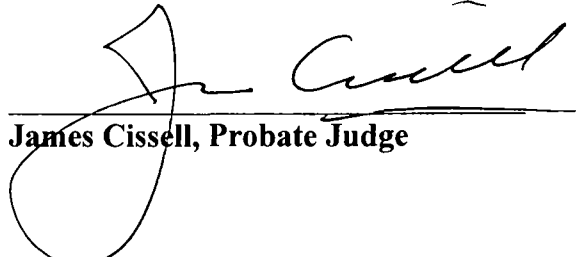

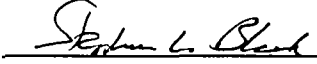
ENTRY AUTHORIZING AMENDMENT OF STATEMENT OF ASSETS

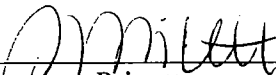
