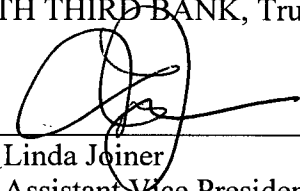
**APPLICATION OF TRUSTEE SEEKING AN ORDER FIXING AND

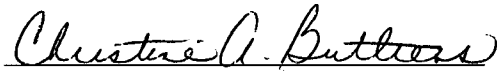
